# Palo Pinto County Fiscal Year 2020 Budget

Notice is hereby given that the Adopted FY 2020 Palo Pinto County Budget is being filed this the 26th day of August, 2019 with the County Clerk of Palo Pinto County and is available for public inspection during office hours to any member of the public. The Adopted Budget is also available on the county's website at [www.co.palo-pinto.tx.us](http://www.co.palo-pinto.tx.us).

As required by Section 111.008 of the Texas Local Government Code, the County of Palo Pinto is providing the following statement on this cover page of its adopted budget for the 2020 fiscal year:

This budget will raise more total property taxes than last year's budget by \$995,173 or 8.54%, and of that amount \$164,715 is tax revenue to be raised from new property added to the tax roll this year.

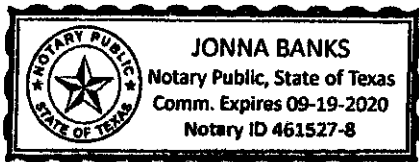

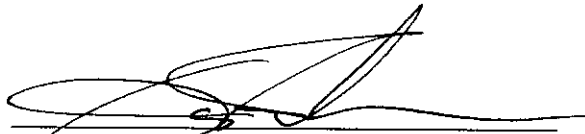

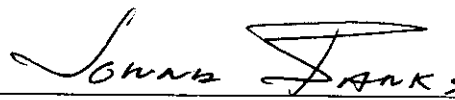

## 2019 TAX RATE

The Adopted Fiscal Year 2020 Palo Pinto County Budget will require a **tax rate increase**. The budgeted expenditures over the budgeted revenues are for expenditures to be funded by committed fund balances and one-time payments to be funded by unassigned fund balance. The 2018 tax rate was \$.400000 per \$100 valuation. The 2019 tax rate will be \$.420000 per \$100 valuation. The breakdown of this rate would be applied as follows:
