2012 TAX RATE

The Adopted Fiscal Year 2013 Palo Pinto County Budget will require an 8% tax rate increase. The budgeted expenditures over the budgeted revenues are for expenditures to be funded by committed fund balances and one-time payments to be funded by unassigned fund balance. The 2011 tax rate was \$.306400 per \$100 valuation. The 2012 tax rate will increase to \$.332000 per \$100 valuation. The breakdown of this rate would be applied as follows:

General Fund: .277800

Road & Bridge: <u>.054200</u>

Maint & Operations .332000

Total Tax Rate .332000
