Notice is hereby given that the Adopted FY 2014 Palo Pinto County Budget is being filed this the 10th day of September, 2013 with the County Clerk of Palo Pinto County and is available for public inspection during office hours to any member of the public. The Proposed Budget is also available on the county's website at www.co.palo-pinto.tx.us.

As required by Section 111.008 of the Texas Local Government Code, the County of Palo Pinto is providing the following statement on this cover page of its adopted budget for the 2014 fiscal year:

This budget will raise more total property taxes than last year's budget by \$932,500 or 11.18%, and of that amount \$291,556 is tax revenue to be raised from new property added to the tax roll this year.

The property tax rates for the 2013 and the 2014 fiscal years are as follows:

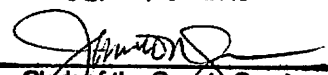

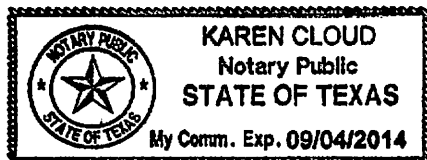

2013 TAX RATE

The Adopted Fiscal Year 2014 Palo Pinto County Budget will require a **6% tax rate increase**. The budgeted expenditures over the budgeted revenues are for expenditures to be funded by committed fund balances and one-time payments to be funded by unassigned fund balance. The 2012 tax rate was \$.332000 per \$100 valuation. The 2013 tax rate will increase to \$.352000 per \$100 valuation. The breakdown of this rate would be applied as follows:
