

ORDINANCE NO. 2026 - 07

**AN ORDINANCE DECLARING UNOPPOSED CANDIDATES ELECTED TO OFFICE PURSUANT TO SECTION 2.053 OF THE TEXAS ELECTION CODE; CANCELING ELECTION PREVIOUSLY ORDERED FOR MAY 2, 2026; AND PROVIDING FOR POSTING A COPY OF THE ORDINANCE.**

**WHEREAS**, on February 3, 2026, an election for City Councilmembers was ordered to be held on May 2, 2026, for the following offices:

- Mayor
- Councilmember Ward 1
- Councilmember Ward 3

**WHEREAS**, the deadline for filing to run for said offices has expired; and

**WHEREAS**, the City Clerk of the City of Mineral Wells, Texas, being the person responsible for the preparation of the official ballot, has certified in writing to the Mineral Wells City Council that only one candidate's name is to be placed on the ballot for each of the offices above mentioned under Section 52.003 of the Texas Election Code and no candidate's name is to be placed on a list of write-in candidates for any of the offices above mentioned under applicable law; and

**WHEREAS**, only the following named persons have filed for each of the offices above mentioned:


- Mayor (At-Large) – Regan Wallace Johnson
- Councilmember Ward 1 – Jonathon Rusher
- Councilmember Ward 3 – Beth Watson

**NOW, THEREFORE**, pursuant to Section 2.053 of the Texas Election Code, the City Council of the City of Mineral Wells, Texas, hereby ordains and declares each of the unopposed candidates named above elected to office as follows:

- Mayor (At-Large) – Regan Wallace Johnson
- Councilmember Ward 1 – Jonathon Rusher
- Councilmember Ward 3 – Beth Watson

**BE IT FURTHER ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINERAL WELLS, TEXAS**, that the election for the above-mentioned offices to be held on May 2, 2026, is hereby canceled and shall not be held. The City Clerk or her designee shall cause a copy of the Ordinance to be posted on May 2, 2026, at the polling place that would have been used in this election.
