

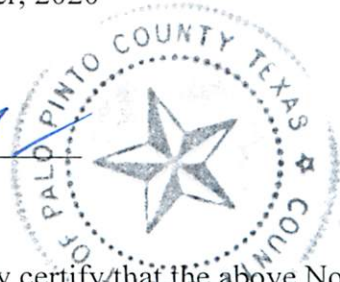
NOTICE OF REGULAR MEETING

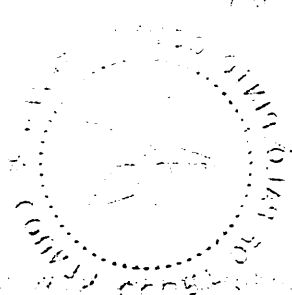
