The following subjects will be discussed, considered, passed, or adopted to-wit:

1. Call To Order;
2. Public Comments and announcements;
This listing is included on the agenda to allow comments, presentations and announcements by Commissioners Court members. Any person may appear at this time and comment on a topic whether that topic appears or does not appear on this agenda. However, members of the Commissioners Court cannot discuss, deliberate or take action on any item or topic not scheduled on this agenda in accordance with existing law. Public comments requiring possible action or deliberation may be placed on a later agenda. Comments and presentations by members of the public will be limited to a maximum of five (5) minutes unless a member of the Court requests additional time for the presenter. Any materials for handout must be furnished by the presenters.
3. Budget Workshop;
4. Discuss and Propose 2022 Tax Rate for Maintenance and Operations for FY2023;
5. Consider/Approve designating a date and time for Public Hearing regarding Tax Revenue increase for FY2023;
6. Consider/Propose FY2023 Palo Pinto County Budget;
7. Consider/Approve designating a date and time for Public Hearing on FY2023 Palo Pinto County Budget;
8. Discuss/Take action on contract with JACOR Building Services Ltd.
9. Executive Session to discuss Section 551.071 (Consultation with Attorney); and Texas Government Code 551.072 (Real Property);
10. Consider/Take Action on items discussed in Executive Session;


