ORDER OF LOCAL STATE OF DISASTER

WHEREAS, Palo Pinto County on the 29th of June 2023, is suffering from an active wildfire, injury, or loss of life or property resulting from extreme heat, drought, and imminent threats of wildfires.

WHEREAS, A wildfire is currently causing imminent threat to homes, lives, and property in Palo Pinto County and evacuation of residents away from the incident is necessary to provide for their public safety and for responding agencies to work the incident.

WHEREAS, the Judge of Palo Pinto County has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,

NOW, THEREFORE, BE IT PROCLAIMED BY THE County Judge of Palo Pinto County:

That a local state of disaster is hereby declared for Palo Pinto County pursuant to §418.108(a) of the *Texas Government Code*.

NOW, THEREFORE, BE IT FURTHER PROCLAIMED BY THE County Judge of Palo Pinto County:

In-order to provide appropriate public safety and care of the citizens of Palo Pinto County as well as provide for responding agency access to impacted areas I hereby instate a mandatory evacuation order for residents located within the areas commonly known as Sportsman World and Gaines Bend being Gaines Bend Road to the South, SH 16 to the East, Hells Gate to the North, Bluff Creek Marina to the West. Mandatory evacuation shall be in effect until rescinded by County Judge.

This local state of disaster order goes into effect immediately, and shall continue for a period not to exceed more than seven days from the date of this declaration unless continued or renewed by the Commissioner's Court of Palo Pinto County, Texas.

COThat this proclamation shall take effect immediately from and after its issuance.
