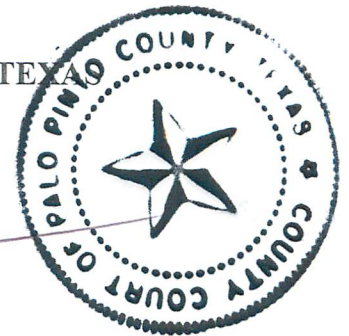
1. Submission of Tax Assessor Collector Continuing Education Transcript for Filling with Court Records in accordance with Property Tax Code 6.231(d) and SB546;

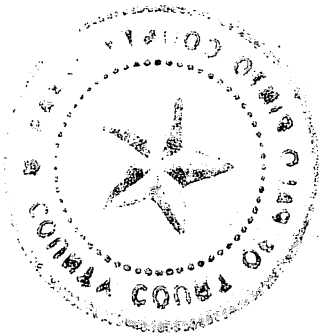
