Dear Mr. Jordan

This is to acknowledge that the Texas Commission on Environmental Quality (TCEQ) Dallas/Fort Worth (DFW) Region Office is in receipt of your request dated May 22, 2025, to burn brush and trees collected from storm debris clean up, located at 850 Gordon Cemetery Rd (Site). The Site is owned and operated by the City of Gordon. Authorization to burn at the Site, in accordance with 30 Texas Administrative Code (30 TAC) §111.215, is granted. Outdoor burning at the Site shall comply with the following conditions:

- Only brush, limbs, trees, and tree trimmings may be burned.
- Shall not be conducted on ozone action days.
- Shall be conducted in accordance with 30 TAC §111.219 (1) through (7)- General Requirements for Allowable Outdoor Burning.
- Requirements of 30 TAC §111.221, which states that you will be responsible for any consequences of the Outdoor Burning.
- Shall comply with all applicable TCEQ regulations concerning all media (Air, Water, Waste).
- Shall not cause nuisance conditions or a traffic hazard, as defined in 30 TAC §101.4 and §101.5.
- Shall notify nearby receptors of the planned burn in advance.
- Notification of intent to burn shall be provided to the TCEQ DFW Region Office no more than one business day prior to ignition by either telephone or email:
R4DFWBurn@tceq.texas.gov.

Authorization may be revoked at any time if the burning causes nuisance conditions, traffic hazards, or is not conducted in accordance with the specified conditions above and as represented in the burn request. This authorization is valid for twelve months from the date of this letter.
