EXERCISE #1: Jacqui's Story (may only submit one essay for this exercise)

Exercise: Watch Jacqui's Story and write an essay reflecting on the impact this story has on you. How will it change your future behaviors? Do you feel the punishment was adequate? This is a three-part story (26 minutes total)

If you submit a:

2-page essay = 3 hours of service

3-page essay = 4 hours of service

4-page essay = 5 hours of service

EXERCISE #2: * CLASS MAY COST A FEE

Participate in a charity walk or run:

Sign up and participate in a local charity walk or run and write an essay on the charity or organization. You must present proof of participation and an essay on the organization or charity sponsoring the event to receive credit. *There may be a fee to participate in walk/run.

Acceptable proof of participation may be a photo of you at the event, a copy of the racer's bib, a receipt of purchase, etc.

EXERCISE #3: *CLASS MAY COST A FEE

Become CPR Certified Exercise:

Currently, about 9 in 10 people who have a cardiac arrest outside the hospital die. But CPR can help improve those odds. If it is performed in the first few minutes of cardiac arrest, CPR can double or triple a person's chance of survival. Having knowledge of first aid and CPR can save lives. If your loved one isn't breathing, knowing how to do CPR can mean the difference between life and death. Emergencies can strike at any time, and it may take several minutes before help arrives. If you complete Exercise #3 you will receive: **4 hours of service Present proof of CPR certification with your name listed. 
EXERCISE #4: Alcohol Awareness Crossword Puzzle
