

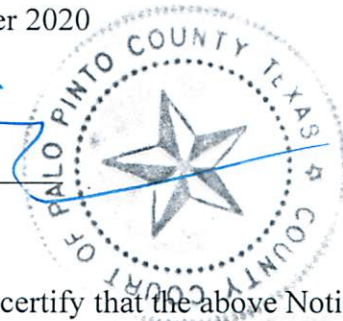
NOTICE OF REGULAR MEETING

9. Adjournment;

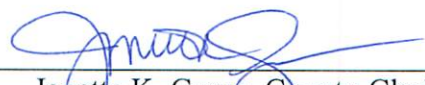
